All Lobbying is Advocacy But Not All Advocacy is Lobbying

Lobbying is communication with a policymaker that takes a position on specific, pending legislation. Less than 3% of nonprofits lobby to advance their mission.

Advocacy is promoting a cause, idea or position that serves the interest of constituents and/or the community served.

Getting Started

- **1. DEFINE:** What are you looking to change or keep the same?
- **2** CONNECT: You are NOT ALONE Consider natural partners in the work.
- **3** IDENTIFY: Connect with legislators via events, email, and social media.

Trust is Currency

Build strong relationships by ensuring that everything you say is factual.
